



Regulations for renting function rooms of Restaurant Colladon Parc

All function rooms are available for all organisations or groups (hereafter “tenant”) wish to enjoy the infrastructure of Colladon Parc through renting. The tenant undertakes to respect the regulations of usage hereunder.

All demands of renting in connection to the activities or manifestations, which have political character, confessional and comparable to any form of proselytism, are in conflict with the core value of the establishment, and meetings with a commercial and lucrative goals open to the public, have to be submitted for approval by the Directorate of the Colladon Parc which has the right to refuse any reservation without any justification.

Renting

The renting of the function room includes the room, the furniture and the materials at disposal are exclusively to be used inside the function room and not elsewhere.

The space outside the function room (notably near the chimney and the hall) is reserved for the residents and is not included in the renting.

Usage of function room and materials of Colladon Parc

The tenant is solely held responsible for deterioration of the room, damages, incidents, loss and theft of all the materials, furniture and personal belongings.

Meal and Coffee break

Only food and beverage provided by Restaurant Jardin des Iles are allowed to be consumed in the function room. Restaurant Jardin des Iles stays at your disposal for coffee breaks, snacks, banquets and meals.

Picnics are forbidden in the establishment and on the terrace.

Smoking

Smoking is prohibited inside the Residence. Ashtrays at the entrance outside the Residence have been used for dumping cigarette butts. The flower boxes and the lawns are not designed for receiving cigarette butts.

Personal effects and belongings

The MRPS declines all responsibilities in case of theft, loss, deterioration of the personal effects and belongings of the tenant.

Security and Tranquillity

In general, the usage of the function rooms should not create noise nor inconvenience to the residents. The usage of candles, incense sticks and other aromatic essences are prohibited in the building. All music and noise likely to be perceived outside the function rooms are interdicted.

Parking

The parking located in front of the Residence is private and is reserved uniquely for visitors of our residents. Parking "outside of the providing space" is interdicted. The control of illegal parking is regular and parking tickets will be issued.

A paid public parking at the corner of Avenue Trembley and Chemin des Coudriers is at the disposal of the tenant and is located at a proximity of the Residence.

Access and Information

For the reason of security and tranquillity of our residents, the entrance doors located between 5 and 7 of Chemin Colladon is not accessible from 17H00 onwards. The access to the function rooms and the restaurant is available from the main entrance situated in the middle of the building.

The staff, at the reception of Colladon Parc situated at the entrance of 7 Chemin de Colladon and Restaurant of Colladon Parc, is at your disposal for any supplementary information.
